



## Rooftop Cinema – Luna Park Sydney

### Terms and Conditions

1. Tickets are sold on behalf of the organization responsible for presenting the event and are subject to the conditions applicable to the event and/or the venue. All claims are the sole responsibility of that organization.
2. Tickets will not be exchanged, refunded or returned after purchase.
3. The right is reserved to add, withdraw or substitute artists and/or vary advertised programs, prices, seating arrangements and audience capacity.
4. Please note that for all restricted films suitable proof of age will be required at the Ticket Office to purchase tickets and also enter the cinema. A driver's license or Valid Photo ID, which displays a DOB, is required as proof of age for restricted films in Australia.
5. Each movie is subject to a viewing rating. They are as follows:
  - **G:** General Viewing. However, G-rating does not conclusively mean a children's film because many of these productions contain content that would not be of interest to children. The content is very mild.
  - **PG:** Parental Guidance recommended. These fields may have content that a parent may have to explain to a child. The content is mild.
  - **M:** Recommended for a mature audience. This movie possesses material that requires a mature perspective. The content is moderate.
  - **MA15+:** The content is strong in impact. MA15+ has strong content and is legally restricted to persons 15 years and over. Cinema staff will request that patrons show proof of their age before allowing them to watch a MA15+ film. Children under the age of 15 will need to be accompanied by their parent or legally appointed guardian for the duration of the film. The appointed guardian/parent must be the purchaser of the tickets for the MA15+ rated film.
6. The management reserves the right to refuse admission and in such event will not refund admission fee paid.
7. Cameras, audio and video recorders will not be permitted. You grant permission to the Presenter to utilise your image, likeness, actions and statements in any live or recorded audio, video, or photographic display or other transmission, exhibition, publication or reproduction made of, or at, the event (regardless of whether before, during or after the event) in any medium or context without further authorisation or compensation.
8. It may be a condition of entry to individual events that a search of person or possessions will be required at the time of entry to the venue.
9. Items considered dangerous will not be permitted inside the venue and must be cloaked.
10. Entry may be refused if tickets are damaged or defaced in any way or are not purchased from other authorized points of sale. Tickets purchased from the Big Top and/or Luna Park Sydney are not permitted to be on sold: this may result in ticket cancellation and refusal of entry.
11. Risk Warning - Section 5M Civil Liability Act 2002. Attendance at the event for which a ticket is sold is a recreational activity and there are risks of injury in attending. By attending you accept these risks and will not make any claim if you are injured.
12. Luna Park Sydney is not responsible for the views, statements and content expressed in any of the events held at this venue.
13. GST will apply to all goods and services supplied through this site.
14. Late arrival may result in non-admittance until a suitable time during the movie
15. While Luna Park Sydney is a large venue, we do have neighbours on our borders that we care about. Please be respectful of our neighbours when entering and leaving the Park by being mindful of noise and taking your rubbish with you.
16. Please note Luna Park Sydney is a strict NO BYO alcohol event site which is strictly enforceable - our liquor licence conditions does not permit consumption of BYO alcohol of any sort. Food items and non-alcoholic drinks can be brought onto site and we do have food vendors available on site.
17. **WET WEATHER POLICY:** As an outdoor event, The Outdoor Cinema at Luna Park Sydney can be impacted by weather. Please note the movies will usually proceed whether in rain or shine. Movie screenings will be cancelled only if the weather poses a safety threat to patrons and staff at Luna Park Sydney.
18. Patrons unwilling to accept this policy and the risk of inclement weather should plan to purchase tickets at the door.
19. We strongly recommend you come prepared with wet weather gear: raincoats and ponchos and something waterproof to sit on in case of rain. Ponchos and blankets will be available to purchase at the cinema (subject to availability).
20. No pets of any kind (with the exception of Service animals) will be allowed on site.
